4. FIRST AID MEASURES

Description of necessary measures

Most important symptoms and effects, both acute and delayed

After eye contact: May cause mild transient irritation. After skin contact: Can cause mild skin irritation with prolonged contact. After Ingestion: Ingestion of large quantities may cause nausea, vomiting, cramps, muscle twitches and shortness of breath. After inhalation: Irritating, in high concentration, to the respiratory tract (nose, throat, and lungs).

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Ventilate spill area if possible. Do not touch spilled material. Stop or reduce any leaks if it is safe to do so. Wear skin, eye and respiratory protection as recommended in Section 8. Keep unnecessary people away; isolate hazard area and deny entry. Ensure clean-up is conducted by trained personnel only.

Environmental Precautions

Methods and materials for containment and cleaning up
