Description

A new foaming cap with every cartridge ensures full-bodied foam with every pump and no clogs. The Food Handler's formula with 0.5% Triclosan removes and kills common germs and bacteria.

The efficiency of the foaming pump helps to give a cost savings. Each activation of the pump releases 0.4ml of soap compared to 1-1.5ml in conventional systems. This reduction can amount to end-user savings of over 40%. Cost comparison documentation can be provided upon request.

Directions for use

- Pump foam in palm of hand and wash thoroughly.
- Rinse thoroughly with potable water after washing.

Skin Compatibility

Under conditions of a Human Patch Test, no evidence of primary irritation or allergic hypersensitivity was found. No negative reactions occurred after 24, 48 and 72 hours.

Storage Information

STOKO Refresh can be stored in a closed container for at least 30 months at room temperature.

All STOKO[®] Skin Care products are tested for stability at temperatures between 23°F and 104°F. When tested at temperatures below 41°F and above 86°F, the products begin to fluctuate in viscosity. Hand cleaners may become cloudy or freeze partially at temperatures of 32°F or below, however, they are usable after thawing.

Additional Information

Occupational skin irritation, frequent washing or harsh climates can lead to dry, rough and chapped skin. This condition can result in irritation/rupture of the outer layer of the skin which impairs its natural protective function. To regenerate damaged tissue after work, the skin should be regularly treated with Stokolan or fragrance-free Stoko Vitan Lotion.
