### Description

STOKO REFRESH<sup>®</sup> 4 in 1 Mild Liquid is a soap-free skin cleanser with strong washing power and good skin compatibility. It thoroughly cleans all light dirt which can be removed without the use of scrubbers and solvents. To improve skin compatibility, STOKO REFRESH<sup>®</sup> 4 in 1 Mild Liquid contains a mild surfactant made up of sugar tensides.

Each refill features the Hygeni-Lok® system which ensures a safe, clean, hygienic product, free from germs and bacteria. The bottle and pump are completely replaced with every changeout providing a fresh new system each time. The high performance patented liquid pump provides ample product for thorough lathering and cleansing.

## Skin Compatibility

Under conditions of a Human Patch Test, no evidence of primary irritation or allergic hypersensitivity was found. No negative reactions occurred after 24, 48 and 72 hours.

### Skin Compatibility Tests

STOKO REFRESH<sup>®</sup> 4 in 1 Mild Liquid skin cleanser has been subjected to clinical testing for its skin compatibility with good results (certified by the Dermatological Clinic, Municipal Hospital, Krefeld). The good skin compatibility of STOKO REFRESH® 4 in 1 Mild Liquid skin cleanser was documented using recognized experimental test methods on human skin, such as the Duhring Chamber Test [2] and the Elbow Washing Test [3] (Research Department, Stockhausen Chemical Factory, Krefeld). In a modified Duhring Chamber Test, according to Frosch and Kligman [2], as well as Kresken et al. [4], STOKO REFRESH<sup>®</sup> 4 in 1 Mild Liquid skin cleanser demonstrated good skin compatibility in comparison to sodium lauryl sulfate, a leading syndet commonly used in surfactants (see table). *TABLE*:

## Storage Information

STOKO REFRESH<sup>®</sup> Mild Liquid Skin Cleanser can be stored in a closed container for at least 30 months at room temperature.

All STOKO<sup>®</sup> Skin Care products are tested for stability at temperatures between 23°F and 104°F. When tested at temperatures below 41°F and above 86°F, the products begin to fluctuate in viscosity. Hand cleaners may become cloudy or freeze partially at temperatures of 32°F or below, however, they are usable after thawing. For optimum dispensing performance, keep from freezing temperatures.

## Additional Information

Occupational skin irritation, frequent washing or harsh climates can lead to dry, rough and chapped skin. This condition can result in irritation/rupture of the outer layer of the skin which impares its natural protective function. To help regenerate damaged tissue after work, the skin should be regularly treated with Stoko Lotion, Stokolan or Stoko SkinRelief. In doing so, the skin is replenished with moisture, lipids and hydrophilic nutrients. People who already have extremely rough or very dry skin are advised to use a before-work, barrier-like cream with high oil content.
