MULTI-USE CARPET CLEANER; FOUR FORMULAS IN ONE: PRE-SPRAY, SPIN CLEAN, EXTRACTION AND SPOTTER

USE INFORMATION:

Always thoroughly vacuum the carpet and remove any attached deposits prior to use. If there is a question of the carpet's colorfastness, always pre-test in an inconspicuous area. The Lightning Blend proportioner can be preset to deliver various dilutions as needed for the different product usages. Use the diluted product as directed.

PRE-SPRAY

- 1. **PLACE** discharge tube into sprayer, select the appropriate dilution 2 ounces per gallon (1:64 ratio)
- 2. PRE-SPRAY the carpet using a tank sprayer or electric sprayer. Allow a 15 minute dwell time for maximum results.
- 3. **EXTRACT or SPIN CLEAN** with **Answer**TM, then force dry the carpet.

- 1. PLACE discharge tube into sprayer, select the appropriate dilution 1 ounce per gallon (1:128 ratio) and fill.
- 2. **SPRAY** or treat the bonnet and carpet.
- 3. SPIN CLEAN using a low speed rotary machine (175-300 rpm) and appropriate driver and a spin

EXTRACTION

- 1. PLACE discharge tube into solution tank, select the appropriate dilution 1 ounce per gallon (1:128 ratio) and fill.
- 2. **EXTRACT**, then force dry the carpet.

SPOTTER

- 1. PLACE discharge tube into sprayer, select the appropriate dilution 4 ounces per gallon (1:32 ratio) and fill.
- 2. **SPRAY** the outer edges of the stain first, then center of stain.
- 3. **BLOT & RINSE:** Blot with a clean cloth and rinse with clean water, then repeat blotting.

FIRST AID:
